## ORDER:

- 1. The AICTE, New Delhi and Government of A.P. in the letter (1) and G.O. (2) read above, have sanctioned certain private Engineering Colleges to the respective Educational Societies and directed them to obtained affiliation either from JNT University, Hyderabad or from the Territorial University. The Secretary and Correspondent of CVS Krishna Murthy Teja Charities, Padmavathipuram, Tirupathi, Chittoor Dist approached the JNT University, Hyderabad and requested for Grant of Temp./Provisional Affiliation to the Chadalawada Ramanamma Engineering College, Renigunta Road, Tirupathi, Chittoor Dist to run First Year B.Tech. course with certain branches vide letter (3) read above. The University has constituted an Expert Committee to examine the existing facilities and plans of the Chadalawada Ramanamma Engineering College, Renigunta Road, Tirupathi, Chittoor Dist sponsored by CVS Krishna Murthy Teja Charities, Padmavathipuram, Tirupathi, Chittoor Dist vide Procs. (4) read above. The Expert Committee has submitted its report with following suggestions and recommended for Grant of Temp./Provisional Affiliation to the said college vide ref (5) read above.
  - 1) The College shall shift EDP cell to Principal room for privacy immediately.
  - 2) The College shall procure more systems before the next academic Year.
- 2. Under the circumstances as stated above, the Vice-Chancellor is pleased to Grant of Temporary/Provisional Affiliation to Chadalawada Ramanamma Engineering College, Renigunta Road, Tirupathi, Chittoor Dist sponsored by CVS Krishna Murthy Teja Charities, Padmavathipuram, Tirupathi, Chittoor Dist to offer B.Tech Course in the following disciplines with the intake shown against each for the Academic Year 2004-2005 as detailed below:

- 3. The Management of the Institute shall provide the facilities to the students as suggested by the Expert Committee as mentioned above under para (1).
- 4. The Renewal of Temporary and Provisional affiliation shall be subject to the following conditions and also general rules of affiliation of the University.
  - 1. The admissions should be made only from the candidates allotted by the Convener, EAMCET.
  - 2. The Institution shall appoint the required number of teachers on a full time basis following the qualifications prescribed by the AICTE/University and procedures laid down by the Government/JNT University.
  - 3. They shall provide necessary facilities like Library, Laboratories etc. as recommended by the inspection Committee/University.
  - 4. They shall admit student according to eligibility and procedure laid down by the University.
  - 5. They shall collect fee as per the fees structures prescribed by the Government/University.
  - 6. The college management shall spend the amount as prescribed by the University each year for purchase of Library books.
  - 7. The college management shall form a separate governing body exclusively for the Engineering College consisting of the specified number of members as prescribed by the University rules of affiliation.
  - 8. The college management shall construct buildings exclusively for the college from their own funds.
  - 9. The management shall not divert any amounts to the Engineering College from any of the existing other Educational Institutions under their control and vice- versa.
  - 10. The college management shall pay the salaries to the staff as prescribed by the Government/UGC/University.
  - 11. The college management shall run and manage the college without any financial aid or assistance from the Government or University either now or in future.
  - 12. The management shall not collect any donation/capitation fee from the students for any purpose.
  - 13. The management shall not change premises of the college without prior approval of the University.
  - 14. The management shall contribute the amount towards conduct of examinations as will be communicated by the University.
  - 15. The management should immediately take action to fulfill the land requirement as per the AICTE norms.
  - 16. 1) Pending construction of permanent building the management shall make available minimum two sheds exclusively to the Engineering College which is minimum required for the college.
  - 2) The erection of equipment to be completed early and practical classes be held regularly.
  - 3) The required teaching and non-teaching staff should be immediately recruited.
  - 17. The management shall meet the requirements of infrastructural facilities. establishment of laboratories and workshops and faculty recruitment as

18. The management shall follow the norms of AICTE and the rules of the affiliation of JNT University in all aspects.

19. The management shall follow the Academic Regulations and examination schedule of JNT University.
